# A Momentous Occasion

Academy members heard **high-profile speakers** from federal and state government agencies and officials from Congress and the White House, who shared the latest information and updates on important and evolving actuarial topics of interest. Keynote speakers at the 2015 Annual Meeting and Public Policy forum included the comptroller general of the United States, the director of the Treasury Department's Office of Financial Research, and the state insurance commissioners who lead the efforts at the NAIC on cyber risk and climate risk.



The annual event is also an excellent way to **earn needed continuing education credit** in all areas of actuarial practice—property/casualty, health, life, pension, and risk management and financial reporting, as well as professionalism CE credits. Attendees at the 2015 meeting were eligible to earn up to 13.6 hours of CE, depending on the sessions they attended.
