


Background





Web of Professionalism: Basis of Self-Regulation



Code of Professional Conduct

Applies to members of the five U.S.-based actuarial organizations

- Academy
- American Society of Enrolled Actuaries (ASEA)
- Casualty Actuarial Society (CAS)
- Conference of Consulting Actuaries (CCA)
- Society of Actuaries (SOA)




The Other Actuarial Organizations

- ASEA a "source of professional organizational support for pension actuaries"
- CAS an "international organization for credentialing and professional education"
- CCA "dedicated to the unique needs of the consulting actuary"
- SOA "Through education and research, the SOA advances actuaries as leaders in measuring and managing risk ..."

The Academy partners with a number of organizations that support underrepresented groups in the actuarial profession.















U.S. Qualification Standards

- Provide guidance to actuaries so that they can determine whether they are qualified to issue Statements of Actuarial Opinion both general and specific
 - Basic education and experience requirements
 - Continuing education requirements
- Actuaries should regularly review their qualifications and may contact the Committee on Qualifications or the Actuarial Board for Counseling and Discipline (ABCD) to address specific questions and concerns.



Actuarial Standards Board (ASB)

- Sets standards for appropriate actuarial practice in the U.S.
- Actuarial Standards of Practice (ASOPs)
 - Describe the procedures an actuary should follow when performing actuarial services
 - Identify what the actuary should disclose when communicating the results of those services



Actuarial Board of Counseling and Discipline (ABCD)

- Counsels actuaries in response to requests for guidance on professional issues
- Investigates complaints about possible violations of the Code of Professional Conduct
 - Recommends disciplinary action with respect to an actuary to any participating organization of which the actuary is a member.
- Mediates disputes between actuaries or between actuaries and others

- Meet basic education requirements (e.g., ASA, ACAS, EA)
- Familiar with U.S. laws and practices in the relevant practice area
- Willing to abide by professional requirements (e.g., Code, USQS, ASOPs)
- Possess good moral character and professional integrity


